## TOWN OF BOW MAR, COLORADO ORDINANCE NO. 339

## AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE TOWN OF BOW MAR REPEALING AND REENACTING SECTION 8.3(1) OF ARTICLE I, CHAPTER 8 OF THE BOW MAR MUNICIPAL CODE, SETTING MAXIMUM SPEED LIMITS ON TOWN STREETS

WHEREAS, the Town of Bow Mar ("Town") is authorized, pursuant to C.R.S. §§ 31-15-401 and 42-4-110(1)(b), to adopt and enforce police power regulations in furtherance of the health, safety, and welfare of its citizens, and specifically, pursuant to C.R.S. § 42-4-1101(7) to adopt the maximum speeds at which vehicles may be operated on Town streets; and

WHEREAS, the Town Board of Trustees finds that it is necessary for the protection of the health, safety, and welfare of the public to set the maximum speeds at which vehicles may be operated on Town streets at twenty (20) miles per hour.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BOW MAR, COLORADO:

## Section 1. Repeal and Reenact Municipal Code Section 8.3(1), Article I, Chapter 8.

Section 8.3(1) of Article I, Chapter 8 of the Bow Mar Municipal Code shall be repealed and reenacted to read as follows:

- Sec. 8-3 Schedules
- (1) The speed limit for all streets in the Town shall be twenty (20) miles per hour.
- **Section 2. Safety Clause.** The Board of Trustees hereby finds, determines, and declares that this ordinance is necessary and proper for the health, safety, and welfare of the Town and its residents.
- <u>Section 3.</u> <u>Severability.</u> If any part, section, subsection, sentence, clause, or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of the ordinance. The Board of Trustees hereby declares that it would have passed the ordinance including each part, section, subsection, sentence, clause, or phrase thereof, irrespective of the fact that one or more part, section, subsection, sentence, clause, or phrase is declared invalid.
- <u>Section 4.</u> Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that such repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.
- <u>Section 5.</u> <u>Codification Amendments.</u> The codifier of the Town's Municipal Code, Municipal Code Corporation, is hereby authorized to make such numerical and formatting changes as may be necessary to incorporate the provisions of this Ordinance within the Bow Mar Municipal Code.
